#### 2.1. Workplace Violence Jenny Moloney

Jenny Moloney attended to present the posters and policy on Workplace Violence. The posters were included in the meeting package. Discussion was held on Baycrest being a healthy and safe work environment. Baycrest has a zero tolerance policy regarding aggression and violence.

#### 2.2. Sharing Dance with People Living with Dementia Roseanne Aleong

There is a new research project with the National Ballet School of Canada. Roseanne presented a short video on the research program. This collaboration created a new dance program called Sharing Dance with Older Adults. This program was meant to bring the power of dance and creative movement to older adults, some of whom may be living with mobility issues or living with cognitive impairment. In 2022 Baycrest, the National Ballet School as well as UHN collaborated to produce a documentary film about the Sharing Dance with Older Adults program. The 3 sites are also collaborating on a research project to evaluate the potential impact of the documentary. We are currently recruiting residents in the Apotex to engage in the study. As well, we are looking to recruit family members who would like to be involved. Please let Lori know if you have any questions or would like to participate in the project.

#### 2.3. Apotex Update Mide Seyi-Ajayi

#### **Masking Changes**

There has been changes made to the masking requirements. If staff are providing direct care or spending 15 minutes or more with a resident and within the 6 feet range, they are required to wear a mask. Also, they must wear a mask if requested by a resident.

#### Staffing

Next Wednesday we will be doing a full day of interviews for PSW staff. We are also looking at our current budget to find funding for increasing the number of staff. We are also adding 2 part time positions in our recreation department with the intention to provide more weekend coverage.

#### **Research Opportunities**

Rosanne Aleong has recently met with our Apotex leaders. There 2 streams of research at Baycrest: the Rotman Research Institute (RRI) which mainly focuses on healthy ageing, and the Centre for Ageing and Brain Health Intervention (CABHI). Mide explained how CABHI can access our database for candidates for research.

#### 2.4. Question & Answer All

#### Care Plans

How are the care plans implemented for new residents and who is checking them? The care plan has always existed. The nurse makes the changes to the care plan. The care plan is communicated by the nurses at the shift change handover. Also, when they log into PCC, they see the care plan. In the past few months, we have hired an Advanced Practice Lead to help assess and educate our staff on how to best use the care plan. We will invite Lisa to a future meeting to discuss this issue.

### 2.1. <u>The Canadian Caregiver Adjustment Needs Tool</u> Adriana Shnall, Program Director, Koschitsky Centre for Innovations in Caregiving

The role of the Koschitsky Centre is to do research, education, training, and best practices around how to help families. Adriana presented the Canadian Caregiver Adjustment Needs Tool for input from the FAC. This is a screening tool to help us understand the needs of families. #### 2.2. High Holiday Update Rabbi Haber

Rabbi Haber presented the plans for the upcoming high holidays. There will be 3 services being held in person. The orthodox service will be held in the synagogue, the conservative service will be held in Wortsman Hall and the reform service will be held in the Winter Garden. Due to limited seating capacity, we will allow 1 family member or caregiver to accompany the resident to services. Rabbi Haber assured us that female caregivers of male residents will not have any issues attending the Orthodox services.

Planning is also underway for Sukkoth. More information will be provided at an upcoming meeting.

#### 2.3. Apotex Update Mide Seyi-Ajayi

#### Care Plans

We are working on the About Me forms to keep them as simple as possible. A care plan can be many pages and the About Me form is a one page quick information guide. We are also providing our staff with education on person-centred care. The nursing team is currently looking at the accuracy of the resident care plans.

#### **Elevators**

Currently 2 of the 3 main elevators are working. Mide has asked that the maintenance issue of the elevators be escalated in priority. We have been waiting for parts for over a month. We have a consultant coming in to assess our elevators.

#### **Long Term Care funding**

We are being creative with how we are using the government funding in the Apotex. The majority of care happens during the day. We are recruiting for 12 float positions to cover the 6 floors to ease up the RPN's work. We are also looking to recruit for night PSW's.

#### 2.4. Update on recent Ministry Inspection

We had an inspection which was conducted in June/July to review our submitted critical incidents. This is the second inspection in a row where we had no compliance orders.

#### 2.5. FAC Elections –2023

Co-Chairs Shari-Ann Rosenberg, Andrea Gregor and Rose Printz were elected, by acclamation.

#### <u>Food</u>

The quality of some of the food is not very tasty and sometimes it is hard. We have recently made some improvements through the resident food committee. Options are given to the residents.
